#### Finance Director Lori Vahle

Lori presented the break down for the 2 rates for the new fire truck. One is from Farmer's Bank and the other one is from Stockyard Banks. They are both at 3.75% interest rate. There is a 10-year and a 15-year term. Lori recommends that we go with the 10-year term.

Councilmember Bathje asked about how we ended up purchasing the fire truck since at the last meeting we had an intent to purchase. Attorney Gullette stated that another city was meeting to purchase the same truck and since they only make these trucks every 24-32 months we had to act quickly. He talked to Kentucky League of Cities and they agreed that this was an emergency. The concern was that we would be without a truck for 24-32 months. An emergency declaration was signed and executed by the Mayor and filed with the Chief Financial Officer of the city. After more discussion on the rate information, Councilmember Riel made the motion, seconded

After more discussion on the rate information, Councilmember Riel made the motion, seconded by Councilmember Brumfield that we go with Farmer's Bank for the 10-year term at 3.75% with the understanding that Lori is going to verify the accuracy of the numbers given to us. #### REPORTS FROM THE FLOOR

Community Service Center Director Koby Miller reported on the Homeless Committee meeting. She stated that this is not a problem to be solved. We are trying to earn the trust of these broken people. We are trying to find a place for winter respite housing. At the last meeting we talked to Johnny Adams who is the Jessamine County Emergency Director. We are working with Johnny towards opening the Blue Building in Nicholasville during the cold winter months. They have cots and blankets. There are qualifications that have to be met before the homeless can stay at the Blue Building. They cannot have a warrant for their arrest, not a sex-offender and they cannot be

intoxicated. If the Blue Building is not available, we are looking for hotels that they can be housed at. We will need volunteers to help with transportation to these places. This is the first step in the process.
