Mayor Rainwater stated that the city had accepted a bid of \$332,100 for the 2023 street repaving project from the Lexington Quarry Company. The Municipal Road Aid account has \$313,201. Dave Carlstedt requested that the city borrow \$18,000 from surplus until the Municipal Road Aid fund is replenished in February 2024. Councilmember Metcalfe made the motion, seconded by Councilmember Deyer, to approve the transfer of funds. There was no discussion. All members voted aye.
