

CITY OF WILMORE MINUTES
June 3, 2024

The Wilmore City Council met for a regular session Monday, June 3, 2024, at 6:00 p.m. with Mayor Pro Tem Leonard Fitch presiding. Council members present were Jim Brumfield, Kim Deyer, David Riel, Andy Bathje, Wes Metcalfe, and Attorney Bobby Gullette, Jr.

MAYOR REPORT/PRESENTATIONS

APPROVAL OF MINUTES

Councilmember Brumfield made the motion, seconded by Councilmember Deyer, to approve the Minutes of May 20, 2024. There was no discussion, all members voted aye.

OLD BUSINESS

FY24 Amended Budget – Finance Director Lori Vahle stated that upcoming end of the year purchases will require adjustments to the FY24 Amended Budget. She asked that the vote on the second reading be postponed until June 17, 2024, Council meeting. The Council agreed.

FY25 Proposed Budget – Lori Vahle asked that the vote on the second reading of the FY25 Proposed Budget also be postponed until the June 17, 2024, Council meeting. The Council agreed.

Municipal Road Aid – Councilmember Riel made the motion, seconded by Councilmember Brumfield, to authorize Mayor Rainwater to sign the Municipal Road Aid Program Agreement. There was no discussion, all members voted aye.

Health Insurance Renewal – Lori Vahle stated, after consulting with KLC, that she chose a different plan to keep costs down.

Ordinance 2024-1 (An Ordinance Prohibiting All Cannabis Business Operations in the City of Wilmore) – Dr. John McDaniel, owner of Med-Save Pharmacy in Wilmore, made a short presentation explaining the pending cannabis legislation. After some discussion, Councilmember Brumfield made the motion, seconded by Councilmember Deyer, to approve Ordinance 2024-1. Councilmember Brumfield requested a roll call for the vote. Councilmembers Brumfield, Deyer, Riel and Metcalfe voted yes. Councilmember Bathje voted no.

Resolution 2024-4 (Related to Cleaner Water Program) – After a brief discussion with Utilities Director Dave Carlstedt, Councilmember Riel made the motion, seconded by Kim Deyer, to adopt Resolution 2024-4. There was no discussion, all members voted aye.


