

CITY OF WILMORE MINUTES

July 15, 2024

The Wilmore City Council met for a regular session Monday, July 15, 2024, at 6:00 p.m. with Mayor Harold Rainwater presiding. Councilmembers present were Leonard Fitch, Jim Brumfield, Kim Deyer, David Riel, Wes Metcalfe, and Attorney Bobby Gullette, Jr.

APPROVAL OF MINUTES

Councilmember Deyer made the motion, seconded by Councilmember Riel, to approve the Minutes of July 1, 2024. There was no discussion, all members voted aye.

OLD BUSINESS

Ordinance 2024-7 (An Ordinance Amending the FY25 Budget) – 2nd Reading to include the \$750,000 Granary Project CDBG Grant. Councilmember Deyer made the motion, seconded by Councilmember Riel, to approve Ordinance 2024-7. There was no discussion, all members voted aye.

NEW BUSINESS

Mayor Rainwater made the recommendation to reappoint Dave Carlstedt as a NWJC Joint Tourism Commissioner representing the City of Wilmore. Councilmember Brumfield made the motion, seconded by Councilmember Deyer, to reappoint Dave Carlstedt. There was no discussion, all members voted aye.

Chris Montgomery with the Jessamine County/City of Wilmore Joint Planning Commission made the recommendation for a Zone Map Amendment for 206 S Maple St. to change the zoning from R-2 Residential to R-3 Residential. Councilmember Riel made the motion, seconded by Councilmember Wes Metcalfe, to approve the motion. After a brief discussion, all members voted aye.
