

## **CITY OF WILMORE MINUTES**

### **June 2, 2025**

The Wilmore City Council convened for a regular session on Monday, June 2, 2025, at 6:00 p.m., with Mayor Harold Rainwater presiding. Present were Councilmembers Leonard Fitch, Jim Brumfield, David Riel, Andy Bathje, Wes Metcalfe, Sharon Moore, and City Attorney Bobby Gullette, Jr.

### **Approval of Minutes**

Councilmember Riel moved, seconded by Councilmember Moore, to approve the minutes of May 19, 2025. There was no discussion, all members voted aye.

### **Mayor's Report**

Mayor Rainwater presented Hunter Neff with a key to the city recognizing his work on the Wilmore Elementary playground presentation.

### **Old Business**

#### **ORDINANCE 2025-1 AN ORDINANCE CHANGING THE WILMORE COUNCIL MEETING TIME – Mayor Rainwater**

No vote was taken at Mayor Rainwater's request to save time for budget discussions. Councilmember Riel moved, seconded by Councilmember Moore, to postpone the vote to a future meeting. There was no discussion, all members voted aye.

### **New Business**

#### **ORDINANCE 2025-2 AN ORDINANCE AMENDING THE FY25 BUDGET – Lori Vahle**

There was no discussion. Councilmember Bathje moved, seconded by Councilmember Metcalfe to approve the first reading of the amended budget. There was no discussion, all members voted aye.

#### **ORDINANCE 2025-3 AN ORDINANCE PROPOSING THE FY26 BUDGET – Lori Vahle**

After some discussion, Councilmember Riel moved, seconded by Councilmember Moore, to approve the first reading of the proposed budget. Councilmembers Fitch, Brumfield, Riel, Metcalfe, and Moore voted aye. Councilmember Bathje voted nay.

#### **RFH CPAs Consultants Audit Engagement Letter for FY2024-25-Lori Vahle**

After some discussion. Councilmember Brumfield moved, seconded by Councilmember Riel to authorize Mayor Rainwater to sign the engagement letter. There was no discussion, all members voted aye.

### **COMMENTS FROM ATTORNEY GULLETTE**

Attorney Gullette addressed Mayor Rainwater and the City Council regarding the proposed

Roseglade Farm Development. He clarified that the Council's involvement in the development process is limited, unless it chooses to authorize development within the area designated as a conservation easement on the approved development plan. Attorney Gullette also provided an overview of the procedural history concerning Roseglade's litigation against the city.
