APPROVAL OF MINUTES:

Councilmember Baier moved to approve the minutes of the August 7, 2017 regular meeting; seconded by Councilmember Cooper. There being no discussion, all members voted aye.

Councilmember Brumfield moved to approve the Special Called Meeting minutes of July 31, 2017, seconded by Councilmember Deyer. There being no discussion, all members voted aye.

OLD BUSINESS

NORFOLK SOUTHERN & CITY HALL PARKING LOT LEASE

The City Hall parking lot is on a right of way has been on a railroad right of way for years. The leasing agent has presented a lease to the City and they are asking us to pay \$2400 per year to lease the parking lot.

The City has concerns about the lease. Some of the wording is restrictive and the city parking lot is only allowed to be used for City Hall business and it does not allow for the Farmer's Market and festivals. Attorney Gullette suggested that Dave Carlstedt send Jason an e-mail stating that the City has some concerns about the lease and to copy Attorney Gullette in the e-mail.

Councilmember Brumfield made a motion to approve Ordinance 6-17 using the compensating rate for 2017, seconded by Councilmember Baier. There being no discussion, all members voted aye.

SIDEWALK & ROAD COMMITTEE PROPOSAL TO PAVE WOODSPOINTE WAY

Councilmember Brumfield made a motion to approve Banta Lane, Woodspointe Way, Butler Blvd, Lowry Lane, Thacker Drive and Johnson Court and to take all but \$150,000 from the MRA Fund and transfer the rest of the money from the Surplus Fund, seconded by Councilmember Riel. Councilmember Riel asked if this includes the curbs and drains

foe Banta Lane. It does not include either of these. Councilmember Deyer asked what the cost of Johnson Court and Thacker Drive would be. Johnson Court would cost approximately \$18,000 and Thacker Drive would be \$20,000. There being no further discussion, all members voted aye.

Councilmember Baier made a motion to approve Resolution 2017-6, seconded by Councilmember Cooper. There being no discussion, all members voted aye.
